#### **Intended Use**

Non-sterile, single use, medical examination gloves are intended to prevent transmission of a wide variety of diseases to both patients and health care personnel. Specifically, gloves are intended to act as a barrier between the health care provider and patients to prevent contamination between patient and caregiver.

The gloves are an effective means of protecting against infectious disease and are intended to be used with additional Personal Protective Equipment as mandated in the Public Health Agencies Guidelines on infectious disease prevention and control.
